NIMBUS GROUP APPOINTS HERZOG MARINECENTER AS NEW AQUADOR DEALER IN SWITZERLAND

Nimbus Group AB (publ) has appointed Herzog Marinecenter AG as the new dealer of boats under the Aquador brand for the Swiss market. Herzog Marinecenter AG is already a dealer of Nimbus boats in Switzerland and has established a strong presence around Lake Lucerne in the Swiss Alps.
